This contract is made between:

The Terms of this Contract are as follows:

- 1. The Offering. Estavan I Renato I Guerra will give, via the hand of the Renato family's scrivener, to the signatory, a document that the Renato Family understand to have been written by Abraxus of Urizen and used to pay for his passage back to Imperial Lands in the year 67 VE.
- 2. The Price. In return, the signatory commits that, within a year and a day from the signing of this contract, they will have completed no less than two of the following three tasks:
 - 2.1 The Exemplification of Emperor Ahraz. The freeborn have no Paragons and few Exemplars

recognised by the Synod. This is an oversight and insult. Without Emperor Ahraz, there would be no Orc Wreachers who spread The Way to Imperial Orcs. The Renato Family believes this most assuredly meets the Sign of Salvation. Liberating the orcs has been benefitted the Empire and meets the Sign of Renevolence. The Renato Family has no presence, or influence, in the Synod, but believes passionately and virtuously that this should come to pass.

The signatory will secure Emperor Ahraz's exemplification by one, or more, Synod Assemblies.

2.2 — The Aspirants to the Throne. The Renato Lamily wishes the Senate to direct, or exhort, all those who have an eye on the Throne to provide their names to the Civil Service so that this list may be published. Any persons that do not do so will have to answer for their lack of Ambition and Courage on the day that their intentions are declared in the Senate. This list would enable parties, such as the Renato Lamily, to know whom they might contact and consider putting their support behind.

The signatory will secure a successful Senate motion to this effect.

2.3 — The Interdiction of an Autumn Curse. The Renato family contains many who walk the Virtue Path of

Prosperity. We believe this path is the surest way to swift resurrection and ascension, and threats to prosperity are a threat to the supernatural and spiritual wellbeing of humanity. The magics of Autumn contain a curse ritual that may be performed that is the antithesis of Prosperity. This curse, named Like Water Through Your Lingers, is vile and corrupting. Yet the casting of this curse is still legal under Imperial Law. The Renato Lamily desires the Conclave to use its powers of interdiction to declare this curse an act of Sorcery and therefore a crime against Imperial Law.

The signatory will secure a successful Conclave declaration to this effect.

- 3. The Penalty. If one year and one day after the signing of this contract, the signatory has failed to complete two of the three above tasks, they agree to receive a penalty relating to the tasks they failed to complete:
- 3.1 Voluntary Excommunication. If the signatory failed to complete the Exemplification of Ahraz, they will agree to present themselves to Assembly of Ambition and request Excommunication for a duration of no less than four years for failure to live up to Ambition's demands.

- 3.2 Legal Sanction. If the signatory failed to complete the Aspirants to the Throne, they will agree to present themselves to the magistrates and request punishment befitting an oathbreaker.
- 3.3 Magical Punishment. If the signatory failed to secure the Interdiction of an Autumn Curse, then magicians from the Renato Lamily will come and lay a curse upon them, and they will agree to provide, or pay the market rate for, the mana used in the curse.
- 4. Clarification. To be clear, the signatory need only complete two of the three tasks to be protected from the consequences of all three tasks. In the event that the documents are proven to not be the work of Abraxus of Arizen, which the Renato Lamily believe in good faith, then this contract shall be null and void.
